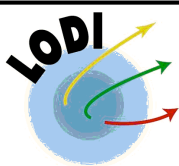

5 FIRE-FIGHTING MEASURES

Flammable class	: Extremely flammable.

7 HANDLING AND STORAGE

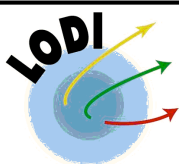

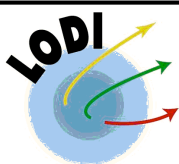
